## Presentation by the William Cobbett Society

Mr Charles Stuart and Mr Richard Thomas gave a short presentation on the work of the William Cobbett Society and the preparations for the commemoration of the 250th Anniversary of William Cobbett's birth on 9th March 1763. William Cobbett was one of Farnham's most famous sons and to celebrate his anniversary a programme of events is being planned which includes two new books of his writings, published by the Ashgate publishers, Cobbett Walks around Farnham, an exhibition of his work at the museum and a planned reception at the House of Commons. A new play about his life is likely to be performed in the Maltings and it was hoped journalism students at the University of Creative Arts would prepare some pieces for the website. The Cobbett Society hoped other organisations would add their own events to celebrate Cobbett and support the

#### C144/011 **Minutes**

The Minutes of the Farnham Town Council meeting held on Thursday 15<sup>th</sup> March 2012 were agreed subject to the addition of Cllr Parlett to the list of apologies (rather than attendees) and the correction of Mr Alasdair Cockburn's name, and Mrs Celia Sandars name.

#### C145/011 Disclosures of Interests

- i) Cllr Stephen O'Grady declared a personal and prejudicial interest in relation to Item 6 (Annex B items 6 & 7), items 10, 11 and 12 as an Executive Member of Waverley Borough Council
- ii) Cllr Julia Potts declared a personal and prejudicial interest in relation to Item 6 (Annex B items 6 & 7), items 10, 11 and 12 as an Executive Member of Waverley Borough Council
- iii) Cllr Pat Frost declared a personal interest in relation to Item 6 (items 6 and 7) on the agenda as a member of Waverley Borough Council.
  - In response to a query, the Town Clerk commented that other twin-hatted councillors (Cockburn, Hargreaves, Hill, Steel and Ward) had the same declaration as had been previously advised.

## C146/011 Statements by the Public

i) Mr David Savage congratulated (to acclaim from the public gallery) the Mayor, Town Clerk and staff for the excellent way the Town Council organised and conducted the Annual Town Meeting. He hoped that the Council had received updated figures of the estimated net income which Waverley Borough Council would receive annually from the completion of

- the proposed East Street development and that councillors might give the approximate date the figures were received.
- ii) Mr Richard Sandars congratulated and thanked Farnham Town Councillors, the Town Clerk and his staff for the detailed work undertaken in preparing Farnham's response to Waverley Borough Council's proposed Core Strategy. The response addresses positively many of the concerns expressed by Farnham residents over the future protection and sustainable development of the town and surrounding area. He drew attention to five areas: inadequacies of Farnham's existing infrastructure and the impact of cross border development; the potential for future housing development at Dunsfold; the statutory requirements of the EU directive on Special Protection Areas and SANGS and the protection of Farnham Park; the very serious impact of current and increased air pollution; and the need for a western by-pass to solve Farnham's increasing traffic problems. Mr Sanders hoped town councillors would impress upon Waverley the seriousness of the issues raised in Farnham's response.
- iii) Mr Stephen Cochrane said that if appeared that councillors had been advised by Waverley Borough Council that if the East Street contract was cancelled the council could potentially be liable for millions of pound of compensation to the developer. He advised that when the contract was signed in 2003 there was an initial long-stop date (extended to 21st December 2011) with 4 conditions precedent (road closure, planning consent, viability and land assembly) before the contract could go unconditional. Mr Cochrane said the conditions had not been met and under the contract between Waverley and Crest Nicholson (clause 3.71) either party could cancel and (under clause 3.81 each party) would be liable for its own costs and have no claim against each other. Mr Cochrane said Farnham Town Council should consider what the legal position is and consider taking its own legal advice as to whether Waverley Borough Council can walk without compensation to the develop.

## C147/011 Town Mayor's Announcements

- i) The Mayor commented on her recent visit to the 229 Air Squadron and noted the numbers had increased to over 50 and that the cadets were doing excellent work with the community and charity.
- ii) The Mayor had had a positive meeting with SaBRE who were supporting employers who take on services personnel. She hoped it would be possible to build on the Freedom of the Borough given to the Princess of Wales' Royal Regiment by developing a new relationship.
- iii) The Mayor reported on a number of engagements she had attended with the Mayors of Tandridge and Whitehill and Bordon and the High Sherriff of Surrey.
- iv) The Mayor encouraged young people to complete the survey being undertaken by the Waverley Youth Council on what facilities need to be provided for young people in Farnham.

#### **WORKING GROUP NOTES**

## Strategy & Finance Working Group of 27th March

Cllr Ward introduced the notes of the Strategy and Finance Working Group held on 27<sup>th</sup> March.

C148/011

Cllr O'Grady commented on the proposal to charge charities for the Tea Tents at events. The Town Clerk said that challenging income targets had been set for events during the year, and this was one way of helping meet the targets. Charities had been told that if they could not meet the fee it could be met by a grant from the Town Council but all the dates had been taken. Cllr Frost felt the income was small for Farnham but was a significant part of the takings on the day and proposed, seconded by Councillor Attfield, that the fee be waived and that attempts be made to find the income from elsewhere.

#### Resolved that:

the fees for charities running tea tents at Farnham Town Council events be waived.

C149/011

Members noted the report on write offs and that the targeted savings for 2011/12 had been delivered and that there had been an increase in income for the cemeteries service in the last quarter meaning that the anticipated outturn for 2011/12 would be positive.

#### Resolved that:

the aged debtors totalling £570.10 be written off as uneconomic to pursue and that a contra totalling £2222 be made for a debtor superseded by a subsequent invoice.

C150/11

Cllr Ward introduced the Information Publication Scheme and the Records Retention Scheme attached as Annex I and Annex 2 to Appendix B. It was noted that having such a scheme was complementary to Freedom of Information requirements. Cllr O'Grady suggested that Insurance related document should be kept for 70 years and that general documents and ephemera would normally be destroyed after a maximum of two years.

#### **RESOLVED** that:

the Information Publication Scheme and Records Retention scheme at Annex I and Annex 2 to Appendix B be adopted subject to the agreed amendments.

Cllr Potts and Cllr O'Grady left the meeting at this point

#### CI5I/011 Farnham Museum

Members noted that Waverley Borough Council had asked Farnham Town Council if it would be interested in discussing the transfer of the museum management to Farnham Town Council. Members also noted that arrangements had been put in place for a contract with Farnham Maltings and that this was not a real proposal. Cllr Steel confirmed that discussions with consultants and the Maltings had been

underway for some 12 months. Members felt this was just a tickbox exercise by Waverley and could have been handled better.

Members felt that the Maltings was well-placed to manage the museum and that it should be given every chance to make it succeed. After further discussion it was

#### **RESOLVED** that:

- I) the Town Clerk write to Waverley
  - a) expressing disappointment at the unacceptably late notice inviting an interest in running the Museum;
  - b) suggesting that the Maltings be offered a three year rolling contract to ensure the service specification has every chance of success; and
  - c) suggesting that Waverley consider adjusting the contract value upwards in the light of the Maltings' experience in running the museum.

### CI52/011 Community assets

Cllr Cockburn said that the Infrastructure Planning Group was collecting information from across the town but comments from Councillors were still needed. The town council should be preparing a list of community assets to help protect them for the future.

#### **RESOLVED** that:

officers prepare a list of community assets in conjunction with the Infrastructure Planning Task Group as set out in the Localism Act.

## C153/011 Reception Service as an agent of Waverley Borough Council

Members noted the proposal from Waverley Borough Council for Farnham Town Council to run the Locality Office Service as an agent of Waverley Borough Council and that the proposal would result in the transfer of one member of Staff under TUPE but that the fee for managing the service would fully fund the costs of employment. Members agreed that Farnham should take on the role and that the arrangement should be on a rolling basis for a minimum contract period of five years if possible.

### **RESOLVED** that:

the Town Clerk, in conjunction with the Spokesperson for the Council, be authorised to finalise the agreement with Waverley Borough Council to manage the Locality Office Service on an agency basis.

Cllr Potts and Cllr O'Grady returned to the meeting at this point

## CI54/011 Council Chamber Furniture

Cllr Ward outlined the options for tables that had been investigated. It was agreed that further options should be considered and that options for chairs should also be investigated.

#### CI55/011 Review of Members' Allowances

Members noted the situation regarding dependent carers' allowances that were not available to town and parish councils, and favoured the idea of an out of pocket expenses scheme subject to the potential tax position also being clarified.

#### **RESOLVED** that:

a Members' Expense Allowance Scheme be introduced for exceptional Out of Pocket expenses subject to the Town Clerk confirming that such a scheme is permissable for Parish Councils.

## C156/011 Infrastructure Planning Group

Members noted the work done to date by the Infrastructure Planning Group on the response to Waverley on the Core Strategy and the suggestion to invite Dr Beth Conlan of AEA Associates to the June Council meeting to give an overview of air quality issues.

## C157/011 Working Group to be Open to the Public

Further to the proposal to experiment with one Working Group open to the public in 2012/13 it was

the Tourism and Events Working Group be open to the public for the next Council year

### C158/011 Planning Consultative Group

The comments made on recent applications set out in Appendix C and D were taken as read.

#### C159/011 Election to Working Groups 2012/13

The report at Appendix E, setting out Councillor preferences for membership of Working Groups in 2012/13, was discussed. Cllr Cockburn withdrew her name from the list for the Strategy and Finance Working Group and the HR Panel. After a vote for the Strategy and Finance Working Group, the Membership of Working Groups for 2012/13 was agreed as set out at Annex I to these minutes. Members were encouraged to put their names forward to fill the remaining vacancies.

#### **Resolved that**

Membership of Working Groups for 2012/13 be as set out at Annex 1 to these minutes.

#### C160/011 Appointment of Representatives to external bodies for 2012/13

The report at Appendix F, setting out Councillor preferences for acting as representatives on external bodies was discussed. It was agreed that there was an anomaly in that only one residents' group was listed, and it should be removed from the list. Cllr O'Grady suggested that the representative to the Farnham Visitors' Forum should be the Lead Member of the Tourism and Events Working Group, and this was agreed. After further discussion it was

#### Resolved that

The representatives to external bodies for 2012/13 be as set out as in Annex 2 to these minutes.

## C161/10 Annual Town Meeting of Electors

Prior to leaving the meeting Cllr Potts asked to make a statement. She said that she had received a number of positive statements from her constituents about the East Street Scheme. Young people like the idea of a cinema and although she had received three objections, the vast majority of residents she had spoken to want the scheme. She believed the scheme will bring significant benefit long-term for residents.

Cllr O'Grady said that over the past five years the council had been entirely in favour of the scheme and he had yet to hear a single objection to the scheme. When he spoke with his constituents they said "please get on with it".

Cllr Potts and Cllr O'Grady left the meeting at this point

The Town Clerk reported that thee had been good presentations by Lead Members on the work of the council, its finances and accounts. There had been two parts to the meeting – the first a report of the council year and the second focussing on East Street. There had been comments about engaging young people more using electronic engagement and there had been two motions. The first was "Are you in favour of the current East Street Development" with I vote for, I20 against and five recorded abstentions. The second motion at the end of the evening was "Are you in favour of Waverley quitting the current contract with the developers of East Street on I7th April?". The vote was I00 for, 0 against and 2 abstentions.

Members reported on comments by the public who said that the presentations by Lead Members at the Annual Town Meeting were excellent and asked that John Collins be thanked for enabling the video overflow for the 170 attendees.

Cllr Steel said that he had been unable to attend but had received around 50 email and telephone calls from people updating him after the meeting. Everyone said they were amazed at the breadth of town council services, the excellence of the presentations and the excellent chairing of the evening

Cllr Beaman complimented Cllr Ward on a sterling job in his presentation on the council's year and the questions he answered (agreed by members).

C162/011

Cllr Attfield reported on a survey he and Cllr Ricketts had undertaken since the meeting with residents in his ward. He felt the attendance at the Annual meeting where he estimated the average age must have been 65 could not represent the views of the people of Farnham and he thought the results of the votes at the meeting were potentially flawed. The survey he and Cllr Ricketts had undertaken sought the views of 170 residents in their ward. There had been a 21% response with 75% in favour and 21.5% against.

## C163/011 Waverley Borough Council Core Strategy

Cllr Cockburn introduced the report at Appendix G which was the result of several iterations of comments from Councillors and others. Cllr Frost said that County

Councillors had met recently and were adamant that infrastructure issues needed to be addressed. After further discussion emphasising the importance of what was the draft response it was

#### **RESOLVED** that

Farnham Town Council's response to Waverley Borough Council's Core Strategy as set out at Appendix G be approved.

#### C164/011 **Motion**

Cllr Beaman proposed the following motion "Given the changing situation in Farnham town centre and the long time-lag since the East Street scheme was first conceived, the Town Clerk is requested to write to Waverley Borough Council to ask Waverley members to engage the local community as represented by Farnham Town Council and other interested stakeholders (e.g. Residents' Associations, the Farnham Society) in a full, open and informed debate on the current scheme for the regeneration of East Street.

In particular, this debate should consider the viability of the scheme in the current economic climate, the suitability of the present configuration of proposed residential development and the figures on which the provision of retail space are based."

Cllr Beaman said East Street remained contentious. He was not against retail development, but he was concerned about the traffic increase and the impact on air quality. The style of the development was now sympathetic to Farnham but the open space land should be transferred to Farnham Town Council. The views of those with concerns are portrayed as being a vocal minority but the concerns are not of the minority. He stressed that "Farnham is our town, and we need a voice".

The motion was seconded by Cllr Steel. He said that the motion was not for or against the scheme but it was about acting responsibly. East Street fills 30% of the town centre and will change the town. After 2007, the new Waverley administration started talking with Crest Nicholson and they changed the design. The world has changed a lot in the last three years but Farnham Town Council has never been invited to sit around a table and discuss the scheme. Farnham should have a say. Traffic will be a problem, and gridlock will turn shoppers away. It is essential that Farnham Town Council can influence the final design.

Councillor Cockburn said that the Neighbourhood Planning process to date had involved meetings with the Chamber of Commerce, estate agents and developers who had made comments on the scheme. All had specifically mentioned East Street and queried aspects of the scheme – with almost identical points raised in relation to the nature of the residential elements.

Cllr Frost said she could not support the motion. She understood where Councillor Beaman was coming from but there was an existing application granted,. The time for debate on the scheme would be if the application failed. The application was due for renewal in August and it could then be renegotiated. Until then, the existing application was binding.

Cllr Attfield said that if the current scheme failed then the Town Council will want input and to be engaged in the process.

Cllr Genziani said that normally there is a three year period to start work after a planning permission or it lapses. The developer could build a trench and then carry on when it liked but he expected Waverley would not allow that approach.

Cllr Ricketts was surprised at the email poll and level of support. However he couldn't see why Farnham Town Council couldn't have a voice and discuss matters such as air quality. Farnham needed a voice and he could not see why the Town Council could not have it now.

After a vote which was carried by 8 votes to 3 it was

# **RESOLVED** that: the motion be approved.

## C165/011 Reports from Other Councils

- i) Cllr Frost reported that the Farnham Low Emission Strategy which impacted on HGV vehicles and air quality showed that Surrey CC was both listening and acting on concerns that had been raised.
- ii) Cllr Frost reported on the Utility Company Task Group that was addressing poor quality works. The task group was keen to hear views that councillors may have on the issue. The proposal is that contractors would be fined if works overran.
- iii) In response to a question from Cllr Beaman on the Bus Review Consultation, Cllr Frost said that the work had not yet been completed and she would confirm the outcome when she could.

## C166/011 Reports from Outside Bodies

- i) Cllr Cockburn reported on the difficulties being faced by the Brightwells Gostrey Centre as a result of the continuing delays in the East Street development. The Centre wished to develop new activities but the building is no longer fit for purpose and there was a decline in numbers as a result.
- ii) Cllr Frost reported on the Wrecclesham Community Centre and that the Youth Worker post had been lost. She noted that the repairs to the roof were still outstanding.
- iii) Cllr Attfield reported that the Farnham Quarry Liaison Group was looking for a new name and asked for suggestions.
- iv) Cllr Beaman reported on the recent meeting of the Police Authority and expressed concern that the new arrangements would mean a loss of corporate knowledge. He suggested a speaker be invited to do a presentation on the changes to a future meeting.

The Town Mayor closed the meeting at 9.21 pm
